Overview: In 2024, the United States exported nearly \$100 million of vegetable preparations (excl. potatoes) and juice to Japan, making Japan the #3 overseas market for these U.S. exports. The United States accounted for 11 percent of Japan's total vegetable preparations and juice imports. The years below correspond to Japan's fiscal year beginning April 1.
